SHORT RENTAL AGREEMENT

(Trailers, Generators, Power Tools & Farming Implements)

1. PARTIES

This agreement is between **Mlilogix PTY LTD** ("Mlilogix") and the undersigned customer ("the Hirer").

2. EQUIPMENT RENTED

The Hirer rents the equipment described below from Mlilogix. All accessories issued form part of the rental.

3. RENTAL PERIOD

Rental begins on collection/delivery and ends only once the equipment is returned and inspected by Mlilogix.

4. PAYMENT TERMS (CASHLESS)

Mlilogix is a **cashless business**. No cash payments are accepted. Rental fees and deposits must be paid in full before collection/delivery. Proof of payment is not confirmation until funds clear. Deposits may be used for damages, cleaning, late returns, fuel, missing items, or recovery costs.

5. INSPECTION & ACCEPTANCE

The Hirer must inspect the equipment before leaving Mlilogix. If no defects are recorded at collection, the equipment is deemed accepted in good condition.

6. USE, RESPONSIBILITY & SAFETY

The Hirer is responsible for safe and lawful use of the equipment and confirms they are competent to operate it. The Hirer may not sub-rent, lend, or allow unauthorised persons to use the equipment. The Hirer may not modify or repair equipment without written consent.

7. TOWING & TRAILERS (CRITICAL)

The Hirer warrants that the towing vehicle is roadworthy, licensed, insured, and suitable. The Hirer accepts all risk relating to towing and transport. Loads carried (including livestock, goods, vehicles, or equipment) are at the Hirer's sole risk. Overloading is strictly prohibited.

8. RETURN, DAMAGE & CLEANING

Equipment must be returned in the same condition, fair wear and tear excepted. The Hirer is liable for all damage, breakages, missing parts, tyre damage, and excessive wear. Cleaning fees apply if equipment is returned excessively dirty (mud, manure, cement, oil, etc.).

9. LATE RETURNS

Late returns will be charged as follows:

- Extra day rental + **15%** inconvenience fee if pre-communicated
- Extra day rental + **30%** inconvenience fee if not communicated

Failure to return or communicate within 4 hours may be reported to SAPS.

10. LOSS & THEFT

The Hirer is strictly liable for loss or theft from collection until return acceptance. Theft/loss must be reported to Mlilogix and SAPS immediately.

11. LIABILITY & INDEMNITY

The Hirer uses equipment entirely at own risk. Mlilogix is not liable for injury, death, loss of income, or consequential damages. The Hirer indemnifies Mlilogix against claims arising from use, towing, or possession of the equipment.

12. PRIVACY (POPIA)

The Hirer consents to Mlilogix processing personal information in line with POPIA and the Mlilogix Privacy Policy.

13. GOVERNING LAW

This agreement is governed by the laws of the Republic of South Africa.
